

Brindabella Ski Club Email and Social Media Policy

Brindabella Ski Club has created a new Social Media Policy. Due to the Brindabella Ski Club Facebook Group being used by the Club and it's Members, the Committee deems it appropriate to develop a standard terms of use.

Facebook has become a communication tool used by the BSC Committee to provide Brindabella Ski Club Facebook Group users with updates on various Club interests. Any Member communication posted by the Committee on the Brindabella Ski Club Facebook Group will also continue to be communicated by traditional methods, including and not limited to, an all Member email, Christie and/or postal mail out. If you are a BSC Facebook Group user and not a current Member of Brindabella Ski Club you will not receive email communications.

The Club has commenced using Mail Chimp, an email service that provides individual Members greater freedom to manage the emails they receive from the Club. Email will continue to be a communication tool used by the Committee.

Brindabella Ski Club Facebook Group - Terms of Use and Rules

The terms of use and rules apply to Brindabella Ski Club Members and Brindabella Ski Club Facebook Group members (non-BSC members).

You are responsible for your use of the Brindabella Ski Club Facebook Group, for any Content you post to the Page, and for any consequences thereof.

Posting content to Facebook
